IX. Church Union Material.

The material in this section appears to have come from different sources as is evidenced by the names of E.H. Oliver, D.S. Dix, Walter C. Murray and other individuals being written on some items. The material might also have been given to the Conference Archives at different times. Ultimately it was brought together under "Church Union Material" by Conference archivists. This subject has been retained in the present arrangement even though many of the publications could well have been filed with the Presbyterian or Methodist Church material in sections I, II, IV or V.

A. Provincial Church Union Committee, 1921 - 1925.

This Committee was formed on July 26, 1923 by representatives of the Saskatchewan Methodist Conference and the Presbyterian Synod of Saskatchewan to take preliminary steps to effect Church Union in Saskatchewan. Representatives of the Congregational Churches were also invited to be on the Committee.

Ephraim Scott which was published in newspapers, circular letters sent by the National Committee on Church Union primarily concerned with gaining support for the pro-union vote, and voting returns.
