Dates: 1944-2004 (inclusive) ; 1960-1996 (predominant)

Extent: 3.5 meters of textual records, 16 audio cassettes, 6 photographs, 1 video cassette, memorabilia.

Biography: Frank Emerson Coburn was born in Toronto, Ontario, on 25 April 1912. He earned both a BA (1936) and MD (1939) from the University of Toronto, and from 1940-1943 received postgraduate psychiatric training at the University of Iowa. From 1943 to 1946 he served as a psychiatric specialist for the Royal Canadian Army Medical Corps. Following the end of the war, Coburn returned to the University of Iowa as an assistant professor; and remained there until accepting a position with the University of Saskatchewan in 1955 as associate professor, Psychiatry. By 1957 he had been promoted to full professor. In addition to his academic career, Coburn was active in the community. He helped form the Unitarian Fellowship in Saskatoon, and served as its first president; ran for Alderman; and was active in the NDP, serving as president of the Saskatchewan NDP and running (unsuccessfully) for office. He was a member of the planning group for the Saskatoon Community Clinic, and served on the boards of the Saskatoon Community Health Foundation and AIDS Saskatoon. He passed away in 2004.

Scope and Content: This fonds contains materials relating to Coburn's work as a psychiatrist, as well as records relating to his involvement in community affairs, particularly relating to issues of social welfare, community health, and politics.

Arrangement: It has been organized into 7 series:
