Biography: Walter Charles Murray was born 12 May 1866 in Studholm parish, King's county, New Brunswick. He started his academic career at the University of New Brunswick, receiving a BA in 1886. After earning a grammar school license at the provincial Normal School, Murray went to University of Edinburgh as the Canadian Gilchrist scholar, and received a MA in philosophy in 1891. After a brief period of study in Berlin, Murray returned to UNB as Professor of Philosophy and Economics. From 1892 to 1908, he was Munro Professor of Philosophy and lecturer in Education at Dalhousie University. During this time Murray married Christine Cameron, whom he had known since grade school; they subsequently had three daughters. In 1908 he was appointed the University of Saskatchewan's first President, a position he held until his retirement in 1937. In conjunction with his duties at the University of Saskatchewan, Murray served on a number of commissions, boards and councils. Upon his retirement he was named President Emeritus and remained active in the local community until his death in March 1945.

“The University of Saskatchewan developed as a university state supported but not state controlled. For almost thirty years it was dominated by one man, Walter Charles Murray, the first president. Murray created a traditional university which not only taught the classics, literature, languages, philosophy, and history, but also emphasized the development of professional colleges and the teach of the sciences as a means of raising the level of education in the province and of providing solutions to the many problems it faced. Under Murray the university virtually became the sole source of post-secondary education in Saskatchewan; open to all who met the requirements. Through its associate course in agriculture it also served as a technical college; through its Department of Extension is served as a community college.”

Scope and content: This series contains materials created and/or acquired by Walter Murray during his tenure as President, from 1908-1937, documenting nearly three decades of the University of Saskatchewan's history including its establishment; the faculty crisis of 1919; the development of the Colleges of Agriculture, Arts & Science, Education, Engineering; Law; Medicine, Pharmacy and the Extension Division; and the financial crisis of the Depression years.
