Biography: Theodore David Regehr was born in Coaldale, Alberta in November of 1937. He obtained his first History degree from the University of Alberta (1959), his second, a M.A., from Carlton University (1963) and finally a Ph.D from the University of Alberta (1967). Regehr joined the faculty at the University of Saskatchewan in 1968 as Assistant Professor of History, became a Full Professor in 1975 and Head of the Department in 1976. He took early retirement in 1996. During his career at the U of S, Regehr taught a variety Canadian History courses to both undergraduate and graduate level classes. Many of his graduate students have gone on to distinguished careers. Prior to coming to the University of Saskatchewan, Regehr worked as an archivist at the National Archives of Canada (1960-1968) raising to Head of the Public Records Section (1965-1968). Among the several senior profession and academic positions he has held are: President of the Mennonite Historical Society of Canada; member of the Mennonite Central Committee's Historical Committee; Chairman of the University of Saskatchewan Faculty Association; President of Saskatchewan Association of University Teachers; member of the Council of the Canadian Historical Association; and founding Chairman of the Western History Section of the Canadian Historical Association. Author and editor of several books and numerous articles, Regehr is a leading authority in Western Canadian history, Canadian business history but is probably best known for his work on Canadian railway history.

Scope and content: This fonds contains correspondence, photographs, notes, reports, minutes, teaching and research material, and manuscripts and drafts documenting the professional and academic activities of Dr. Regehr over the course of his career. Files pertaining to published material include: The Canadian Northern Railway; Wirtschaft und Gesellschaft im Industriezeitalter; Education with a plus : the story of Rosthern Junior College; The Possibilities of Canada are Truly Great, Memoirs 1906-1924 By Martin Nordegg; Remembering Saskatchewan. A History of Rural Saskatchewan; and The Beauharnois Scandal. A Story of Canadian Entrepreneurship and Politics. The research material includes photocopies from several collections: the Laurier; Borden; Meighen; White; Whitney; and Flanelle Papers; and City of Vancouver Records. This fonds also contains records from a number of University Committees: Archives; Budget; International Studies; and College Review; as well as records from the Faculty Association. Dr. Regehr's relationship with several national and provincial heritage organizations are also document.

Other holdings: Some of Dr. Regehr's papers have been deposited elsewhere. Material related to his involvement with the Canadian Mennonite Historical Society are at the Mennonite Heritage Centre at 600 Shaftesbury Bldg. Winnipeg, Manitoba. Materials related to the writing and publication of Mennonites in Canada, 1939-1970. A People Transformed can be found at

B. Wirtschaft Und Gesellschaft Im Industriezeitaler (Economy and Society in an Industrial Age). - 1971-1976.

This international encyclopaedia was to be comprised of four volumes and one index dealing with "the economically and social relevant institutions of the world from about 1750 to the 1970s". Dr. Regehr participation in the project was to revise the "catchword list" for the Canadian section, supply names of leading Canadian historians and their areas of expertise and write three articles: "Canadian National Railways"; "Canadian Transportation Commission"; and "Canadian Post Office". The project was halted after the first volume.

The file contains correspondence, contracts, lists and articles.

C. Education with a plus : the story of Rosthern Junior College by Frank H. Epp. - 1969-1972.

Regehr was a member of a three man "advisory committee for publication" who were responsible for making recommendations pertaining to the writing, revision and publishing of the history of Rosthern College.

D. Nordegg. - The Possibilities of Canada Are Truly Great. Memoirs of Martin Nordegg - 1906-1924. By Martin Nordegg; Edited with an introduction by T.D. Regehr. - nd, 1948, 1968-1974.

Martin Nordegg (Cohen) was a German born emigrant who came to Canada in 1906. Within ten years he had established a coal mine, a railway, and a townsite in Alberta that still bears his name. Regehr came across the Memoirs while doing research on the Canadian Northern Railway at the National Archives of Canada. He approached Mrs. Sonia Nordegg and several Canadian publishers with a proposal to edit the text. In 1971 MacMillan of Canada published the book.
